

AN ACT

An Act to authorize in accordance with Article VIII Section 8 of the Constitution the issue of a total sum of \$60,890 from the Marshall Islands General Fund to provide for the payment of a special non-refundable interim allowance to members of the Nitijela representing Outer Island electoral districts and who are not resident in Majuro to provide for the payment of a per diem allowance to such member of the Nitijela for the period 1 January 1984 - 6 March 1984; and to meet certain immediate accounting problems of the Council of Iroij.

BE IT ENACTED BY THE NITIJELA OF THE MARSHALL ISLANDS:

1 Section 1. Short title and effective date.

2 This Act may be cited as the Supplementary
3 Appropriation Act (Financial Year 1984), and shall come into
4 effect on the date on which it becomes law.

5 Section 2.

6 (1) The sum of \$22,000 is hereby appropriated and
7 may be withdrawn from the Marshall Islands General Fund for
8 the payment of a special interim allowance to members of the
9 Nitijela representing Outer Island electoral districts and who
10 are not resident in Majuro, to enable them to meet the cost
11 of their subsistence in Majuro until the coming into operation
12 of the Appropriation Act for the Financial Year 1985.

13 (2) The sum of \$27,712 is hereby appropriated and
14 may be withdrawn from the Marshall Islands General Fund for
15 the payment of a per diem allowance to such members of the
16 Nitijela as are referred to in Subsection (1), for the period
17 1 January 1984 - 6 March 1984 at the rates existing immediately
18 prior to the coming into operation of the Appropriation Act

1 (Financial Year 1984).

2 (3) Any payment made under the preceding Subsections
3 of this Section shall be a non-refundable payment and shall
4 not be deducted from any allowances payable to such members
5 under the Appropriation Act for the Financial Year 1985
6 notwithstanding the provisions of Section 14(3) of the
7 Appropriation Act (Financial Year 1984).

8 Section 4. The sum of \$11,148 is hereby appropriated and
9 may be withdrawn from the Marshall Islands General Fund and
10 expended for the following purposes of the Council of Iroij
11 and in the amounts specified below:

12	(a) Travel Authorization	\$9,808.00
13	(b) Car Rental	840.00
14	(c) Comsat Bill	300.00
15	(d) Office Supplies	<u>200.00</u>
16	Total	\$11,148.00
