9 **§101. Short title.**

10 This Act may be cited as the Contingencies Fund (Amendment) Act, 2020..

11 **§102. Amendment.**

12 Section 109 (1) is hereby amended to read as follows:

13 **§109. Contingencies Fund.**

14 (1) In accordance with Article VIII, Section 9 (1) of the Constitution, up to
15 \$1,000,000 ~~\$500, and not less than \$200,000~~ is authorized to be
16 advances against the General Fund for purposes of the Contingencies
17 Fund.

18 **§103. Effective Date.**

19 This Act shall come into effect on the date of certification in accordance with
20 Article IV, Section 21, of the Constitution and Rules of Procedures of the
