9 **§101. Short title.**

10 This Act may be cited as the Customary Law (Ralik Chain)(Amendment)
11 Act 2023.

12 **§102. Amendment.**

13 Section 403 of the Customary Law (Ralik Chain) Act is amended as follows:

15 **§403. Irojlaplap domains in the Ralik Chain.**

16 In the Ralik Chain, excluding Ujelang there are and shall be
17 four (4) separate Irojlaplap domains and titles held and
18 exercised by the successors of:

- 19 (a) Irojlaplap Jeimata;
20 (b) Irojlaplap Laelan;
21 (c) Irojlaplap Joel Litokwa; and
22 (d) Irojlaplap ~~Lobokkoj~~ Loeak.


