**A BILL FOR AN ACT** to amend Title 11 Chapter 8 in order to repurpose on the use of the Ministry of Justice Special Revenue Fund for which it is establish under the Chapter.

**BE IT ENACTED BY THE NITIJELA OF THE REPUBLIC OF THE MARSHALL ISLANDS**

**§101. Short title.**

This Act may be cited as the Ministry of Justice Special Revenue Fund (Amendment) Act, 2023.

**§102. Amendment**

(1) Section 803(2) of the Ministry of Justice Special Revenue Fund Act is hereby amended as follows:

**§803. Payment into the Fund.**

.....

(2) The Secretary of Finance is hereby authorized to deposit into the Fund ~~an amount equal to \$400,000~~ of all collections made during a fiscal year.

(2) Section 804(3) of the Ministry of Justice Special Revenue Fund Act is hereby amended by deletion as follows:

**§804. Payments out of the Fund.**

~~(3) The Secretary of Finance shall deposit into the Marshall Islands General Fund any sum of money in excess of \$400,000 from all collections made under Section 803 (1)(a)(b)(c)(d) during a fiscal year.~~

**§103. Effective date**

This Chapter shall take effect on the date of certification in accordance with Article IV, Section 21 of the constitution.

**BILL SUMMARY**

This Bill proposes to amend Sections 803(2) and 804(3) of the Ministry of Justice Special Revenue Fund Act in order to repurpose the use of the Fund.

The objective is to allow the Ministry of Justice access to all collections and revenues paid into the Fund to support its operational costs in accordance with Section 804 of the Act including upgrading and supporting the Marshall Islands Issuance System.
